- III. Greetings and New Introductions
 - a. Danielle Johnson (Wellstar Kennestone), new appointed Region 3 RTAC coordinator
- IV. Financial Report- \$25,375.78 in the Region 3 RTAC budget at this time.
- V. EMS Council Update- provided by EJ Daily
 - a. Region 3 EMS Council met 11/10/22 at 10AM (Hybrid and In person)- great attendance both in person and online.

VI. Georgia Trauma Commission Update- Liz Atkins

- a. November Commission meeting was a rural focused meeting. In October 2022 colleagues from Pennsylvania Trauma System Foundation did consultative visits for 5 level 4 centers in GA due to there not being a formal ACS path for this level of centers. The hope is Region 3 trauma centers can support the development of these level 4's.
- b. Partnering with the Attorney general's office to hopefully establish peer protected confidential case reviews within the region and state.
- c. Next big initiative is the Trauma System Consultative visit (last one was 2009) for the State of GA by the ACS> Additionally they are having a rural focused review. The visit will occur Jan 9-11th and many people from Region 3 may be asked to participate. Jan 9-10th will be help in Cordele (Lake Blackshear Resort) and Jan 11th will be held in Cartersville. This should allow more access for the rural centers.
- d. Next meeting is at Chateau Elan on march 1st, all meeting information is posted on the GTC website.

VII. GQIP update- Gina Solomon

a. Arbor Metric project has been working since 9/27 and the state is working through barriers to make it more useful. Goal is second quarter of 2023 to have reliable data and metrics that are useful. Working to establish standards to feed the date back to the trauma centers to be useful and improve practice. Please reach out to Gina for any other questions. Example- time to definitive care.
