- I. Call to order 1502
- II. Approval of December 2022 Region 3 RTAC Meeting
  - a. Motion to approve by Dr. Kyle Thomas, seconded by Zach Botkin.
  - b. Approved unanimously
- III. Greetings and New Introductions
  - a. Welcome to all new members with introductions made.
- IV. EMS Council Update none provided
- V. Georgia Trauma Commission Update
  - a. Executive Director update (Liz Atkins)
    - i. Commission meeting was held day prior on 3/2/2023 and combined with the annual spring GQIP meeting.
    - ii. Firework revenue (annual) that supplemented the Super Speeder Funds has changed. We now have a trust fund. The Trauma System is growing and trying to be inclusive, which means spreading dedicated funds across all centers. As we approach the end of the fiscal year (\$3.2 million) we will reallocate some items.
    - iii. GQIP is moving forward with getting verified for patient safety organization.
    - iv. Greg Nickel is the new Stop the Bleed Coordinator new contractor position for the trauma commission. Will work closely with Kristal Smith who is the new ACS-COT STB Champion for our state.
    - v. Leftover funding to be distributed to trauma centers and EMS with a focus on level 3 and 4 centers
    - vi. The commission now has a Rehab Committee, as this was identified as an opportunity with the ACS System Consult. Full report from that visit likely to be available in April. Being led by Dr. Ford Fox from Shepherd Center and their first

- meeting was last week. Our state has good bed availability and we look forward to using data to assist in patient placement by identifying gaps.
- vii. Discussion of a state Trauma Plan review and will continue to review prior to official submission.
- viii. Arbor Metrics to get off the ground soon and we are looking forward to this as it will offer region specific data.
  - Dr. Benjamin discussed overview of getting vulnerable populations related to the report discussed at the GTC meeting.
     Was impressed that region 3's data (and most of GA) have good access to care. Also complimented EMS capability and properly triaging to correct centers.
- b. Director Georgia Quality Improvement Program (Gina Solomon)
  - i. Arbor Metric roll out now pushed to September, but two primary metrics have been chosen – Time to Definitive Care and Hip Fracture Repair within 48 hours – to go live from the beginning and will be able to divide data by region.
  - ii. Discussion around opportunities to work with centers that are transferring patients out that could be care for at their facility
  - iii. Goal is to add performance improvement to the summer meeting to further drill down on how we can better serve our populations
- VI. Trauma Plan Finalization Directed by Dr. Benjamin
  - a. Hope is to make each version of this plan more robust and should be treated as a working document
  - b. Danielle noted that yellow highlights were to show where sentences were duplicated and provided edits for clarity
  - Danielle noted that grey highlights were duplicated descriptions and provided edits for improved understanding with addition of organization chart discussed at committee meeting in January
  - d. Nadine suggests change: designated but not verified as Cobb is currently working towards becoming verified. Discussion with Liz Atkins to recommend checking with OEMS to confirm wording, as the state does not designate burn centers. Group determined to keep "one verified and one non-verified" burn center. Additionally, Dr. Renz confirmed pediatric patient's (≥ 15 years) accepted at Cobb. Burn patients at cobb to be ≥ 1 year. All centers asked to report to Dr. Benjamin if any changes to be made to accepting ages.
  - e. Clarification requested on need for burn center leaders to attended each RTAC meeting. Group agreed that we should require participation or a designee to be assigned to attend
  - f. Fire requested to be included in membership as they provide first responder paramedic-level trauma care on the scene alongside EMS/Transport services.
  - g. Field Triage Guidelines discussed. Request to include "MIST 30x30" EMS protocol into the plan and group agreed.
  - h. Discussion on MCI distribution of patient: group agreed that we would like to see the graphic in full view to determine graph vs. wording to be most beneficial for this section.
  - i. Request to the group to view listed program offering and determine if any need to be added
  - New verbiage for injury prevention section provided by Sharon with no objection for edits.

- k. Deadline for final edit submissions is Friday, March 10<sup>th</sup> to Dr. Benjamin and Danielle. Edits will be entered and sent to group for final review.
- Proposed that final draft will be reviewed by group in email to vote and allow for submission to OEMS for review.

## VIII. Coordinator Update – Danielle Johnson

- a. Stop the Bleed: We have touched over 100,000 Georgians with this education program and continue to receive requests on a weekly basis.
  - i. Please register yourself to the National site (stopthebleed.org) to ensure you are a verified instructor
  - ii. QR Code provided to add yourself to the Georgia specific instructor list
  - iii. Our region has many large scale event requests, and we need multiple volunteers to make it happen. It would be great to have a consolidated list of volunteers to reach out to when program requests are made in your area of our region.
  - iv. The Georgia Trauma Commission approved additional organizations to be eligible to receive bleeding control kits for free. The expansion includes other public educational institutions, law enforcement agencies, and government agencies. The first application closed in December. Our region received 14 requests, 6 of which were eligible for kits and we approved for 573 kits to be distributed in and around our region. These will be delivered by the end of the month.
  - v. The next bleeding control kit application period opened in March and will close at the end of the month. If you would like more information please contact Danielle.
